Is the Master of Science in Accountancy program right for me?

Students in the Master of Science in Accountancy program gain invaluable exposure and insight into all functions of a business enterprise, yet focus their coursework on the field of accounting. The program is designed to meet the academic coursework requirements for the Certified Professional Accounting (CPA) examination and to prepare students for professional careers in accounting. This degree program is flexible based on the individual and thus is suitable both for students who have no prior accounting or business coursework as well as those with undergraduate business degrees.

Curriculum

Students complete 30–48 units of coursework depending on whether they have earned a bachelor's degree in business from a recognized university and have completed equivalent courses in business.

As part of the curriculum, students will be required to take classes in Financial Accounting I and II, Strategic Management Accounting, Legal and Professional Responsibilities, and Accounting Ethics.

Accounting elective courses may include Federal Taxation, Audit, Financial Statement Analysis, Accounting Information Systems, and Data Analytics.

With advisor approval, other advanced business electives may be selected from disciplines such as accounting, finance, marketing, management, international business, information systems, and decision sciences.

Admission Criteria

The admissions committee reviews an applicant's overall qualifications and takes the following requirements into consideration:

- Completion of a degree equivalent to a four-year U.S. bachelor's degree in any subject from a recognized university
- 3.0 Grade Point Average or higher
- GMAT exam: verbal, quantitative, integrated reasoning and writing scores. GRE score is also accepted. Either exam must be taken within the last five years. GMAT/GRE exam may be waived.
- TOEFL, IELTS or PTE exam, taken
 within the past two years, is required
 of all applicants who earned their
 undergraduate degree from a
 country where the official language
 is not English.
- Statement of purpose
- Two letters of recommendation
- Résumé


